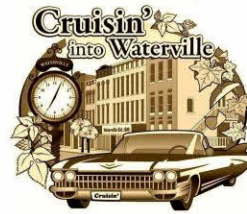

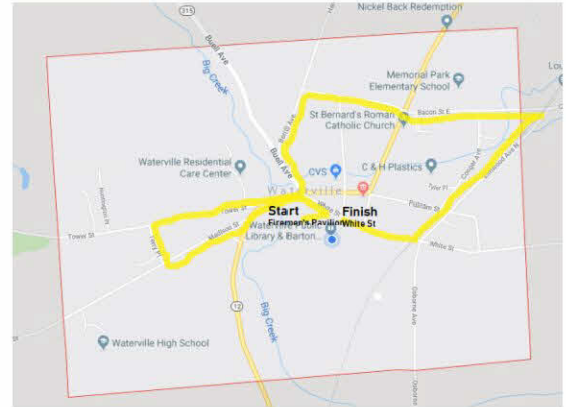
## Road Challenge Route 20 Series
